



## **BATTERUPP PRIVACY POLICY**

### **1. Information We Collect**

We may directly collect the following information about you:

- Email Address
- Technical data, including your MAC address, IP address, mobile device ID information, clicks, and platform and browser type, and similar information

### **2. How We Collect Your Information**

We may collect information about you via:

- Email subscription lists

### **3. How We Use Your Information**

We may use your information to:

- Inform you of new services and products,
- Solicit input and feedback on our products and services.

### **4. Who We Share Your Information With**

Batterupp does not sell, trade, or rent your personal information to others. Batterupp may provide aggregate statistics about our users, sales, traffic patterns, and related site information to reputable third-party vendors, but these statistics will not include personally identifying information.

Batterupp may release personal information when we believe, in good faith, that such release is reasonably necessary to (i) comply with law, (ii) enforce or apply the terms of our user agreement or (iii) protect the rights, property or safety of Batterupp, our users, or others.

## **5. Our Security Measures**

We are committed to protecting your information, and we employ reasonable security measures to do so. Whenever you sign in or enter your personal information, that transmission is encrypted using SSL technology. However, nothing on the Internet is completely secure, and we cannot guarantee the security of your information.

If there is a security breach, we will notify you within 72 hours of first discovering the breach. The method of this notification will include as many forms as deemed necessary to disseminate the information in a timely manner, including email, telephone, message and public announcement.

## **6. Your Consent**

We will only collect your personal identifying information with your express consent. If we decide to change our privacy policy, we will post those changes on our website so that you are always aware of what information we collect, how we use it, and under what circumstances we disclose it.

You may, at any time, withdraw your consent to the storage and use of your personal identifying information. You may contact us via email, telephone or message to withdraw your consent and we will respond within 24 hours to withdraw such consent.

## **7. Right to Access**

We will provide, at your request, confirmation as to whether personal data pertaining to you is being processed, where it is being processed, and for what purpose. We will also provide to you, free of charge, a copy of the personal data being processed in electronic format.

## **8. Right to Erase Personal Data**

We will, at your request, erase all personal data when asked to do so. When you make this request, we will cease further dissemination of the data and halt all processing.

## **9. Data Portability**

We will provide mechanisms for you to receive any previously provided personal data in a commonly used and machine-readable format. You also have the right to request the company transmit the data to another processor, free of charge.

## **10. Privacy By Design.**

We will implement appropriate Privacy By Design principles and implement appropriate technical and organizational measures in an effective way to meet the requirements of the GDPR

and protect your rights. We will process only the data absolutely necessary for the completion of our business and services to you and limit access to personal data to only those employees needing the information to complete the process consented to by the data subject.
